1. I/we the owners request that my/our mare be bred to stallion, Rocket Finder TNT for the 200__ season. If shipping semen, all breeding fees must be paid for before any shipments. All fees will be paid in full before the mare and/or foal are able to leave the farm.

Breeding Fee: \$500.00
Booking Fee: \$50.00
Stallion Service: \$450.00

Multiple Mare Discount: Private treaty, depending on number of breedings desired.

Mare Care: \$12.00 per day, wet or dry
Stall or Paddock Care
Payable Every 30 Days
Or Paid In Full At Time Of Pick Up.

Container Fee: \$50.00 (Fully Refunded Upon Return)

Shipping Fee: Breeding fee includes 1 shipment. Customer would pay for shipping after 1 collection.

2. I/we the mare owners, understand that TNT Appaloosas, being the stallion owners, agree to diligently try to settle my/our mare, and shall have sole discretion of determining the best method of breeding such mare. If, however, for any reason the mare does not settle, I/we will hold TNT Appaloosas harmless. The mare owners may substitute another mare for a re-breeding the same year or the year to follow. Re-breeding will be void after the following year.
3. The breeding season at TNT Appaloosas begins February 1st and closes July 1st.
4. ALL MARES MUST BE ACCOMPANIED BY:
 - a. A COPY OF BOTH SIDES OF HER REGISTRATION PAPERS.
 - b. A CURRENT VETERINARY HEALTH CERTIFICATE, ATTESTING TO THE GOOD HEALTH AND BREEDING SOUNDNESS OF THE MARE AND VERIFY THAT THE MARE IS CURRENT AND UP-TO-DATE ON ALL VACCINATIONS AND HAS BEEN WORMED IN THE LAST 30 DAYS.
 - c. A CURRENT NEGATIVE COGGINS CERTIFICATE.
 - d. All MARES SHALL HAVE A UTERINE CULTURE TO INSURE THAT SHE IS FREE FROM INFECTION AND/OR DISEASE AND VETERINARY VERIFICATIONS OF SUCH SHALL BE PROVIDED TO TNT Appaloosas.
5. I/we understand that if at all possible, I/we leave the mare after breeding to be sonogramed at 18 days after her last breeding date to determine if she has settled. If she has settled, the mare owner may take her home, but agree to have her palpated at 45 days from the last breeding date to ensure pregnancy retention. I/we will provide TNT Appaloosas with the Veterinary's written results of this 45-day check.
6. A "Live Foal Guarantee" by TNT Appaloosas means that the foal resulting from this breeding shall stand and nurse. It is understood that if the mare proves barren, aborts her foal, or if the foal is stillborn a return season will be guaranteed for the following year only provided that proper notification is given to TNT Appaloosas. Proper notification is defined as follows: a written certification by a licensed veterinarian within 7 days that the mare has slipped or produced a non-viable foal. The mare owner certifies that such abortion or death did not result from any act or omission of the owner subsequent the mare's departure from TNT Appaloosas.
7. Mares and foals will be carefully supervised and afforded the best possible care that TNT Appaloosas can provide. But I/we, the mare owner/s, agree that TNT Appaloosas (its owners, employees, veterinarians, or guests) will not be liable for accidents, sickness, injury, and or death to my/our foal, and TNT Appaloosas has my/our permission as the mare owner/s to exercise their own judgment in caring

for my/our mare and or foal. I/we agree to accept full responsibility for any and all veterinary expenses incurred by my/our mare or colt.

8. A Breeder's Certificate will be issued to the mare owner after expenses have been paid in full, and upon notification of live birth of the foal.
9. Booking fee is non refundable.
10. All mares need to broke to lead and tie. All mares must not have shoes on either rear feet.

14. All fees will be paid in full before the mare and/or foal leave the farm.
